Dogs are pack animals by nature and typically enjoy interaction with other dogs. It is important to be aware before putting your dog into an environment where they will be in close contact with other dogs that a dog's language often involves grunts, growls, using their mouths and paws. The staff at Five Points Kennels, Inc. is trained to monitor all dogs playing and take the necessary action in aggressive situations, but it is inevitable that there will be rough playing and rambunctious dogs. This can occasionally lead to scratches, bruises and sometimes punctures and all owners should be aware of this before entering their dog into community playtime.

KENNEL POLICIES:

The dog(s) have no history of aggression or biting towards any person or dog. The owner(s) must disclose any dangers associated with their dogs(s).

The dog(s) do not show increased protection over any food or toy.

Although we do monitor the temperaments of the dogs in playtime, there will be times where dogs show increased energy and playful behaviors. Five Points Kennels, Inc. will not be held responsible for injuries/death occurring in or outside of the playtime facility.

The owner(s) are responsible for any medical care expenses or damages inflicted by their dog(s) while at Five Points Kennels, Inc.

The dogs must be in good health and free of any illnesses or contagious diseases in the last 30 days.

All animals are boarded, groomed and cared for by Five Points Kennels, Inc. (Kennel) without liability for loss, damage from disease, death, running away, theft, fire, injury, self-inflicted injury by pet(s), injury to persons by said pet(s), injury to other animals by said pet(s), or other unavoidable causes when responsible care is provided.

The Kennel has permission to have a veterinarian treat my pet and hospitalize my pet if they in their sole discretion feels it is in the best interest of my pet. Before I remove my pet(s) from the premises, I will pay all charges for boarding, grooming or any other services together with any charges incurred in treating and hospitalizing my pet.

We are not responsible for lost, destroyed or misplaced items.

In the event of poor weather conditions, if Five Points Kennels, Inc. feels it is unsuitable conditions and may be harmful to the dogs to perform community playtimes, they have the option to cancel community playtimes for that day. In the event of a cancellation, the client will not be charge for that playtime.

In the event that Five Points Kennels, Inc. is required to retain the services of any attorney to enforce or defend any term or condition in any way related to this Agreement, the owner shall be responsible for all attorney fees and expenses of the kennels.

Five Points Kennels, Inc. reserves the right to refuse any dog from play time if deemed incompatible in social environments with other dogs.
